

STATE LIBRARY OF NSW – REGIONAL LIBRARY MANAGEMENT MODELS – ONLINE SURVEY

TEXT BOX:

A standalone library – where local governments independently provide library services to their community. The library service is integrated within local government operations and may be part of a wider local government department such as Community Services. Examples include:

- Warringah Library;
- Liverpool City Library;
- Parkes Shire Library;
- Inverell Shire Public Library; and
- Guyra Shire Council Library.

A regional library – where two or more local governments agree that one local government manages library services on behalf of the other(s). Although such arrangements often form within geographically recognised regions, the term ‘regional’ simply denotes the involvement of multiple local governments. Examples include:

- Macquarie Regional Library;
- Riverina Regional Library;
- Central Northern Regional Library; and
- Ryde Hunters Hill Joint Library Service.

A cooperative library – where two or more local governments agree that one local government provides a component or components of library service on behalf of the other(s). Examples include:

- North Western Regional Library
- Southern Tablelands Regional Libraries Cooperative; and
- North West Slopes and Plains Cooperative Library Service.

Some libraries work cooperatively with other libraries, however have not necessarily formalised this arrangement under the Library Act s12. Examples include:

- Shorelink (North Sydney, Lane Cove, Mosman, Manly, Willoughby)
- Mid-North Coast Cooperative Library (Kempsey, Port Macquarie-Hastings)
- Eastern Suburbs Library Cooperative

Note: In 2011, the Library Act 1939 was amended to add Section 12A. This amendment enabled councils to propose alternative models that offer greater flexibility in regional library management arrangements – that is libraries operated on behalf of two or more local councils across NSW.
