#### I affirm

I directly witnessed the incident, which is the subject of the claim and cross-claim.

At approximately 10.30 am, on 10 March 2021, I was walking down Stacey Street, Bankstown, on my way to the train station.

I had pressed the traffic lights, to cross the road at the pedestrian crossing, and was waiting for a green light.

A red Mazda, with number plate CWP 59H was travelling at what appeared to be average speed in the left lane, which was closest to the curb where I was waiting. The car then slowed and stopped as the traffic lights turned orange/red.

The driver of the blue Commodore, who I now know to be John Hughes (the Plaintiff and Cross-Defendant), said words to the effect of 'I am so sorry. It's my fault. I just couldn't stop in time'. The driver of the red Mazda, who I now know to be Samira Khan (the Defendant and Cross-Claimant) started to cry. She said words to the effect of, 'my car is ruined. I can't afford a new car at the moment, and I have no insurance'. John then said words to the effect 'I'll fix this'.

The parties then exchanged details and took photos of the damage.

Before I left, to catch my train, Samira asked me if she could have my details in case she needed me as a witness, and I agreed.
